2. Pallipedia: We are also delighted to announce that Pallium India http://www.palliumindia.org/ will be collaborating with IAHPC to improve and nurture Pallipedia, our free online palliative care dictionary http://www.pallipedia.org

Pallipedia offers visitors two options:

- To search for a term or concept related to the field of Palliative Care. The search capability includes stop words and query language.
- It also accepts the submission of a term or concept related to the field of Palliative Care. Accepted terms and

concepts are automatically indexed in alphabetical order.

The quality of the dictionary is ensured through a set of criteria which has to be met in order for a term to be accepted and uploaded. *Pallipedia* offers only definitions published in peer reviewed journals, reference publications, or resulting from sound consensus based processes. To date, and thanks to Fundacion FEMEBA in Argentina and now Pallium India, the dictionary has 813 terms and 923 definitions. It registers more than 150 visitors per day and has become a useful tool for palliative care workers around the globe.

A Traveling Scholar's Report by Mina Kumari Ranabhat (Nepal)



Mina and Dr. Fraser Black, Medical Director of Victoria Hospice and an IAHPC Board Member

I wish to express my deepest gratitude to IAHPC for providing me a traveling scholarship grant to attend an educational / Twinning committee meeting at the Victoria Hospice Society from *August 7 th to August 21 st* in Victoria BC, Canada.

Without this funding, it would have been impossible for me to attend. The visit was organized by the Victoria Hospice Society for the purpose of exchanging information between our two organizations and helping professional and social collaboration....

The visit was the most important part of the exchange and helped to support the palliative efforts at B.P. Koirala Memorial Cancer Hospital, Bharatpur (BPKMCH), Nepal. My participation provided me with additional new skills and learning opportunities that I can now apply to my job....

I learned their community palliative care program operates 24 hours a day. Each shift being handled by an RN and a counselor. Counselors are not generally available in our hospices in Nepal, neither as a staff member nor as a volunteer....

I was able to give a slide presentation about the Hospice and Community Palliative Care programs at BPKMCH, Nepal and the challenges and needs of the Nepalese people.

I was able to accompany the Palliative Response Team on community calls....

Phenomenology of the subtypes of delirium: phenomenological differences between hyperactive and hypoactive delirium

Delirium is a neuropsychiatric disorder characterized by cognitive alterations, attention and perception disturbances. Delirium is frequent in advanced stages of disease and the symptoms are distressing to both the patients and for their caregivers.

Delirium is classified into subtypes characterized by their psychomotor behaviours: the **hypoactive type** is characterized by decreased reactivity, motor and speech retardation, amimic facial expression; the **hyperactive type** presents with symptoms like agitation, hyperactivity, delusions, aggressiveness, and perceptual disturbances.

The authors examined the difference in phenomenology between hypoactive and hyperactive subtypes of delirium and determined the comparative prevalence of perceptual disturbances (e.g., hallucinations) and delusions in the two subtypes of delirium in patients referred for delirium management to the Memorial Sloan-Kettering Cancer Center (MSKCC) and who also met the DSM-IV criteria for delirium. Data were recorded in an Institutional Review Board which included serial ratings of the Memorial Delirium Assessment Scale (MDAS), cause of delirium, type and dosages of medications used for delirium-related symptom control....

Why I choose this article

Delirium is present in the majority of patients with advanced stages of cancer and is considered a prognostic indicator of survival and in some cases of impending death.

The presence of either hypoactive or hyperactive delirium subtypes is able to create distress in patients, their health caregivers and their family members. Many papers have been written on the assessment and the management of delirium and the related symptoms, however it not easy to provide adequate treatment.

The authors were able to explain, through a revision of the data collected, the differences in phenomenology between hypoactive and hyperactive subtypes of delirium which helps us in our daily clinical practice.
